PROPERTY TAX – PRE-AUTHORIZED PAYMENT PLAN

The following pre-authorized payment plans are available:

- **Instalment Plan**

Annual taxes will be withdrawn in four instalments. Withdrawal amounts and dates will coincide with those listed on the Interim Tax Bill and Final Tax Bill (two withdrawal dates per bill).

- **Semi-Annual Plan**

Annual taxes will be withdrawn in two instalments. The first withdrawal will equal the total amount owing on the Interim Tax Bill and it will be withdrawn on that bill's first listed instalment date. The second withdrawal will equal the total amount owing on the Final Tax Bill and it will be withdrawn on that bill's first listed instalment date.

- **10 Month Plan***

Annual taxes will be withdrawn over a 10-month period either on the 3rd business day (March to December) or the last business day (February to November) of each month.

The first five withdrawals of the year will be based on the Interim Tax Bill and the last five withdrawals will be based on the Final Tax Bill.

How do I join?

1. Complete and sign the Enrollment/Authorization Form on other side
2. Attach your personal cheque marked "**Void**"
3. Send form and cheque by mail or drop off at the Town Hall (drop box during off-hours)

Once enrolled, this authorization will remain in effect until you cancel in writing.

- CHEQUE via Regular Mail or Off-Hours Deposit Box located next to the front door at Town Hall. Post-dated cheques will not be accepted.
- CASH, CHEQUE or DEBIT over the counter at Town Hall. Post-dated cheques will not be accepted.
